



1.4 Whether there is any revision/update of regulation or syllabi, if yes, mention their salient aspects.

B. Ed and M. Ed Curriculums were extended for two years as per the decision of the government of India. A single unit was allotted for both B. Ed and M. Ed. The unit comprises of fifty students for B. Ed in nine optional subjects and thirty five students for M. Ed.

A comprehensive coverage of themes and meticulous field engagement with the child, school and community are targeted by the course structure. The system comprises of three broad inter-related curricular areas – I) Perspectives in Education, II) Curriculum and Pedagogic Studies, and III) Engagement with the Field. All the courses include in-built field-based units of study and projects along with theoretical inputs from an interdisciplinary perspective. Engagement with the field is the curricular component that is meant to holistically link all the courses across the programme, while it also includes special courses for Enhancing Professional Capacities (EPC) of the student teachers. Transaction of the courses is to be done using a variety of approaches, such as, case studies, group presentations, projects, discussions on reflective journals, observations of children, and interactions with the community in multiple socio cultural environments.

Aim of the course is to develop in students an understanding of the curriculum and of linking school knowledge with community life. A variety of investigative projects, that link with curricular area III given below, shall be included to reconstruct concepts from subject knowledge though appropriate pedagogic processes that communicates meaningfully with children.

Optional courses will be offered in areas such as Vocational/Work Education, Health and Physical Education, Peace Education, Guidance and Counseling, or an additional pedagogy course (in another subject at the secondary level or the same subject at the higher secondary level). The M.Ed. programme focuses on developing professionally committed and competent teacher educators, curriculum developers, educational policy analyst, supervisors, school counselors, school principals, educational researchers, educational administrators and educational planners, who can develop education according to the national aspirations and global trends. it also focuses on comprehensive and integrated professional development of the personnel engaged in educational management and administration.


5.4 Details of student support mechanism for coaching for competitive examinations (If any)
